Anyone who would like to appear before the Board or have matters discussed should notify the Board office by **Wednesday, April 20, 2011**, in order to be placed on the agenda. Matters or subjects not on agenda are not guaranteed for discussion at the meeting.

PLEASE NOTE

Please read carefully and fill out completely, any and all forms that are to be submitted to the Board office. In an effort to better serve the funeral profession and the public, The Alabama Board of Funeral Service office has updated many of its forms and applications, installed a new computer system and is currently in the process of having a new licensure program installed. It is very important that all forms are filled out completely so that all the information can be entered into the licensure program correctly in an effort to improve the office operations.

REMINDER

Anyone who has not renewed their funeral establishment, funeral director, embalmer or practical embalmer license, may still do so with a \$25.00 late penalty until March 31, 2011. If you failed to submit your paperwork and fee, including late penalty, for renewal by the March 31st deadline, the license(s) will be considered lapsed. At which time the establishment (s) or individual must cease operations and or practice. Any paperwork and fees received after the March 31st deadline, must go before the Board for reactivation approval.
