## **Administrative Laws**

Act No. 2011-623 (Senate Bill 94) became effective October 1, 2011 causing significant changes to the Alabama Funeral Service Law. As a result of these changes, it has become necessary for the Funeral Service Administrative Laws to be amended.

In accordance with Section 34-13-26 and the Alabama Administrative Code, Code of Alabama, 1975, the Board reviewed Senate Bill 94 and the current administrative laws, voted on and filed with the Legislative Reference Service Administrative Procedure Division proposed amendments to the administrative law. Notification of intended action will be mailed to the last address on file for each licensee. Written, verbal or electronic mail comments regarding the proposed amendments will be accepted by the Board until January 4, 2012. A public hearing regarding those comments will be held during the Board's January 25, 2011 meeting at 11:00 a.m., in Room P-103 of the Gordon Person Building, 50 N. Ripley St., Montgomery, Alabama.
