Steps to taking the Alabama State Art or Science,:

- 1. Submit application to the Board office for permanent license.
- 2. Eligibility will be verified and sent to The Conference by the Board staff.
- 3. Applicants must then go to The Conference website at <a href="www.theconferenceonline.org">www.theconferenceonline.org</a> to submit their exam application and payment.
- 4. Please keep in mind, processing takes anywhere from 2-3 business days. The Conference must have your eligibility, application, and payment to schedule. You will be notified through email once you have been processed and you are able to schedule.
