CONTINUING EDUCATION

GET STARTED!

The 2020-2022 reporting period began October 1, 2020. ALL licensees (that's cremationists too), are required to complete eight (8) hours of board approved continuing education during the period of October 1, 2020 through October 1, 2022. Courses completed prior to October 1, 2020 may not be used for the 2022 renewal. Do not send completion certificates to the Board's office, they are for your records. Providers report all completions electronically.

ONLINE PROFILE...

Licensees can view reported course completions via "online services" on the Board's web site www.fsb.alabama.gov. Please take the time to review your online profile and CE completions that have reported. Questions related to a course completion should be directed to the provider who provided the program. Course completions are uploaded by the provider via the online portal.

BBP/UP... WHAT YOU NEED TO KNOW

Included in the required eight hours of continuing education, licensees must complete BOARD approved courses in ETHICS and BLOODBORNE PATHOGEN/UNIVERSAL PRECAUTIONS. There are no hour requirements for these two courses. Most online providers offer courses that will satisfy these two requirements. Confirm that the provider and courses are BOARD approved prior to registering. A list of approved providers is attached to this newsletter for your convenience.

Cremationists, whose crematory operator training course is over four years old, must complete a re-fresher course, crematory operator training, or a course in cremation approved by the Board, prior to the license being renewed.







If you will be celebrating your 65th birthday before October 1, 2022 and have 10 years of service in the

funeral industry, congratulations, you are exempt from the continuing education requirements! Many wishes for a happy year if you have celebrated a birthday since the last Quarterly Newsletter.

Applicants for the Alabama State Art or Science exam shall:

- 1. Submit application for permanentlicense to the Board's office.
- 2. Eligibility will be verified by the Board's staff and sent to The Conference.
- 3. Applicants must register with The Conference at www.theconferenceonline.org to submit their exam application and payment.
- 4. Please keep in mind, processing takes anywhere from 2-3 business days. The Conference must have your eligibility, application, and payment to schedule an exam. You will be notified by email when you are eligible to schedule.

THE CONFERENCE

The Funeral Director and Embalmer's exams are given by The Conference through Pearson VUE testing centers at five locations statewide. The exam application and exam fee are submitted to The Conference by the applicant. The licensing application, application fee, and affidavits shall be submitted to the Board office.

Alabama Funeral Services Statues <u>Code of Alabama 1975</u>, Section 34-13-9 Pricing requirements.

"Funeral service, cemetery service, and funeral merchandise pricing shall conform to rules established by the Federal Trade Commission..." The inspection citation for pricing requirements that do not meet rules established

by the Federal Trade Commission is *\$500.00*, or Administrative Fines *up to \$2500.00 per violation*. Establishments may submit price lists to the Board's office, which will be reviewed for compliance with the Federal Trade Commission Funeral Rule.
