5.	Embalming Procedures	
	a)	Locate and raise vessels for injection/drainage
	b)	Inject embalming fluid into vessels
	c)	Adjust and monitor the rate of flow and pressure of embalming machine
	d)	Establish fluid distribution and monitor drainage
	e)	Treat discoloration, bruises, lacerations
	f)	Perform proper treatment for special cases (infants, autopsies, trauma, burns, donations)
	g)	Evaluate fluid distribution and take corrective measures, if necessary
	h)	Close/suture embalming incision(s) use of trocar button
	i)	Perform autopsy repair if needed
	j)	Aspirate, inject and/or treat cavities

6.	Post	Post Embalming Care	
	a)	Perform Hypodermic treatment as necessary	
	b)	Treat orifices	
	c)	Groom hands and nails	
	d)	Remove medical devises/implants	
	e)	Bathe and sanitize	
	f)	Clean and disinfect the preparation/embalming room and instruments	
	g)	Dispose of bio-hazardous waste in compliance with OSHA standards	
	h)	Complete embalming case report	

7.	Cremation	
	a)	Confirm identity of deceased prior to cremation
	b)	Document and remove jewelry and other personal effects as instructed
	c)	Obtain consent to remove implanted devices
	d)	Remove medical devices/implants
	e)	Place deceased in state required combustible container
	f)	Position remains in casket

8.	Restorative art, Cosmetizing, Dressing and Casketing	
	a)	Perform restoration procedure as authorized by the authorizing agent
	b)	Cosmetize
	c)	Dress deceased to ensure proper placement of clothes
	d)	Place and position deceased in casket/container
	e)	Ensure proper appearance
	f)	Adjust cosmetics or lighting if needed for viewing
